### Waiver and Release Agreement

The Madison Community Center and the Madison Aquatic Center is committed to conducting its activities in a safe manner and holds the safety of participants in a high regard. The Madison Community Center and Madison Aquatic Center continually strives to reduce such risks, and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for this program/activity must recognize that there is an inherent risk of injury when choosing to participate in recreational activities. You are solely responsible for determining if you or your minor child/ward are physically fit and/or skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity. Despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury when participating in any recreational activity/program. Understandably, not all hazards and dangers can be foreseen. Participants must understand that certain risks, dangers and injuries due to acts of God, inclement weather, slipping, falling, equipment failure in supervision, premise defects and all other circumstances inherent to recreational activities/programs exists. In this regard, it must be recognized that it is impossible for the Madison Community Center and Madison Aquatic Center to guarantee absolute safety. Please read this form carefully and be aware that in signing up and participating in this facility's programs/activity, you will be assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you and your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this facility's program/activity.

I recognize and acknowledge that there are certain risks of physical injury to participants in this program/activity, and I voluntarily agree to assume the full risk of any and all injuries, damages, or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. ### **MADISON AQUATIC CENTER RULES AND POLICIES**

For your safety, please observe all posted rules and policies.*

#### **AGE GUIDELINES:**

- A guardian or responsible person 16 years of age or older must be *in* the water within an arm's reach actively supervising children age **3 years and younger**.
- A guardian or responsible person 16 years of age or older **must be present in the pool area with any child ages 4 through 6** or else the child must get out of the pool. No exceptions.

#### **GENERAL USAGE POLICIES**

- The Aquatic Center is not responsible for lost or stolen items. Lockers located on the north desk next to the building; please bring a padlock to secure items. All belongs and locks **MUST BE REMOVED** at the end of each day. The department reserves to right to cut off any locks left overnight and to put contents of the locker in the lost and found.
- Items kept on deck must be stored under chairs or along the far edge of the deck; loose items will not be allowed within 12 feet of the water's edge.
- Towles may be used at the water's edge as long as someone is sitting on them. Unattended towels pose a tripping and/or safety problem for other patrons. Towles are **NOT** allowed in the water.
- This facility does not guarantee that chaise lounges or chairs will be available to all patrons. Loungers and chairs must be kept 12 feet from the water's edge.
- Paper or cloth diapers are not allowed. Swim Diapers must be worn on deck and in the water by any person not trained to use the restrooms.
- Diapers must be changed at changing stations only.
- Lifejackets, floatables, water-wings, or inflatables are **NOT ALLOWED** in the pool. Swimwear with floats sewn into the suit are allowed. Goggles and small pool toys are allowed at manger's discretion.
- Swimsuits **MUST** be worn. Nylon or Spandex tank tops and/or shorts, or swim-armor are allowed with swimsuit. **NO** t-shirts allowed in the pool for any reason.
- Patrons must shower before entering the pool. Patrons with open wounds such as rashes, skin diseases, or open sores are not allowed. Patrons with eye infections are not allowed.
- No outside food, gum, or glass containers in the pool area. Water is acceptable in a plastic container

#### **ZERO DEPTH AND OTTER SLIDE RULES**

- One child at a time in each lane; Must be in forward, seated position, feet first. Children **CANNOT** be placed in the lap of someone else. You may not catch children off the slide. Must be able to walk up steps on own to use the slide.
- The slide in zero-depth area is intended for youth use only. Weight limits are not to exceed 125 lbs.

#### **DIVING BOARD RULES**

- Divers must wait until previous person makes it to the ladder before they can jump.
- Divers must be able to swim in deep water.
- No goggles, mask, or floatation devices allowed off the board.
- One bounce before jump. Forward only for all skills, including dives and flips. Straight jumps only.

#### **LARGE SLIDE RULES**

- All riders must be at least 42" tall. Maximum rider weight is 300 lbs (136 kg.)
- All riders must ride feet first, lying on their back or in a sitting position.
- Only one rider at a time. No trains or chains of riders permitted.
- No tubes, mats, or lifejackets are permitted on water slide.
- No goggles, mask, or floatation devices allowed off the board.
- Leave the exit area **IMMEDIATELY**.
